REGULARITY OF THE FREE BOUNDARY FOR TWO-PHASE PROBLEMS GOVERNED BY DIVERGENCE FORM EQUATIONS AND APPLICATIONS

DANIELA DE SILVA, FAUSTO FERRARI, AND SANDRO SALSA

ABSTRACT. We study a class of two-phase inhomogeneous free boundary problems governed by elliptic equations in divergence form. In particular we prove that Lipschitz or flat free boundaries are $C^{1,\gamma}$. Our results apply to the classical Prandtl-Bachelor model in fluid dynamics.

1. INTRODUCTION AND STATEMENTS OF THE MAIN THEOREMS

This paper is a further step in the development of the theory for general elliptic inhomogeneous two-phase free boundary problems, after [DFS1], [DFS2], [DFS3]. In particular, in [DFS3], via Perron's method, we constructed a Lipschitz viscosity solution to problems governed by elliptic equations in divergence form with Hölder continuous coefficients and we proved weak measure theoretical regularity properties, such as “flatness” of the free boundary in a neighborhood of each point of its reduced part. Here, as in [DFS1, DFS2] we prove that flat or Lipschitz free boundaries are locally $C^{1,\gamma}$. It is worthwhile to notice that, in absence of distributed sources and with Lipschitz coefficients, these regularity results were obtained in [FS1], [FS2], while they are new even in the homogeneous case when the coefficients are assumed to be merely Hölder continuous.

Our setting is the following. Let Ω be a bounded Lipschitz domain in \mathbb{R}^n and let $A = \{a_{ij}(x)\}_{1 \leq i,j \leq n}$ be a symmetric matrix with Hölder continuous coefficients in Ω , $A \in C^{0,\bar{\gamma}}(\Omega)$, which is uniformly elliptic, i.e.

$$\lambda |\xi|^2 \leq \sum_{i,j=1}^n a_{ij}(x) \xi_i \xi_j \leq \Lambda |\xi|^2, \quad \forall x \in \Omega, \quad \xi \in \mathbb{R}^n$$

for some $0 < \lambda \leq \Lambda$. Denote by

$$\mathcal{L} := \operatorname{div}(A(x) \nabla \cdot).$$

Let $f \in L^\infty(\Omega)$. We consider the two-phase inhomogeneous free boundary problem

$$(1.1) \quad \begin{cases} \mathcal{L}u = f & \text{in } \Omega^+(u) = \{u > 0\} \\ \mathcal{L}u = f & \text{in } \Omega^-(u) = \{u \leq 0\}^\circ \\ |\nabla_A u^+|^2 - |\nabla_A u^-|^2 = 1 & \text{on } F(u) = \partial\{u > 0\} \cap \Omega, \end{cases}$$

where $|\nabla_A u|^2 := \langle A \nabla u, \nabla u \rangle$.

Since our emphasis is on the class of operators, we decided to avoid further technicalities by considering only a particular, although significant, free boundary

condition. The extension to a general free boundary condition of the type $|\nabla u^+| = G(|\nabla u^-|, \nu, x)$, where $\nu = \nu(x)$ denotes the unit normal to $F(u)$ at x pointing towards $\Omega^+(u)$, can be achieved without much difficulty as in [DFS1], if $G(\beta, x, \nu)$ is strictly increasing in β , Lipschitz continuous in the first and in the third argument, Hölder continuous in the second argument, $G(0) := \inf_{x \in \Omega, |\nu|=1} G(0, x, \nu) > 0$, and moreover $\eta^{-N}G(\eta, x, \nu)$ is strictly decreasing in η uniformly in x, ν .

We now recall the notion of viscosity solution. Here we give it in terms of test functions. In the last section we will use an equivalent notion in terms of asymptotic developments at one side regular points of the free boundary.

Definition 1.1. Given $u, \varphi \in C(\Omega)$, we say that φ touches u by below (resp. above) at $x_0 \in \Omega$ if $u(x_0) = \varphi(x_0)$, and

$$u(x) \geq \varphi(x) \quad (\text{resp. } u(x) \leq \varphi(x)) \quad \text{in a neighborhood } O \text{ of } x_0.$$

If this inequality is strict in $O \setminus \{x_0\}$, we say that φ touches u strictly by below (resp. above).

Definition 1.2. Let u be a continuous function in Ω . We say that u is a viscosity solution to (1.1) in Ω , if the following conditions are satisfied:

- (i) $\mathcal{L}u = f$ in $\Omega^+(u) \cup \Omega^-(u)$ in the weak sense;
- (ii) Let $x_0 \in F(u)$ and $v \in C^{1,\bar{\gamma}}(\overline{B^+(v)}) \cap C^{1,\bar{\gamma}}(\overline{B^-(v)})$ ($B = B_\delta(x_0)$) with $F(v) \in C^2$. If v touches u by below (resp. above) at $x_0 \in F(v)$, then

$$|\nabla_A v^+(x_0)|^2 - |\nabla_A v^-(x_0)|^2 \leq 1 \quad (\text{resp. } \geq).$$

We also need the definition of comparison subsolution (resp. supersolution).

Definition 1.3. We say that $v \in C(\Omega)$ is a $C^{1,\bar{\gamma}}$ strict (comparison) subsolution (resp. supersolution) to (1.1) in Ω , if $v \in C^{1,\bar{\gamma}}(\overline{\Omega^+(v)}) \cap C^{1,\bar{\gamma}}(\overline{\Omega^-(v)})$, $F(v) \in C^2$, and the following conditions are satisfied:

- (i) $\mathcal{L}v > f$ (resp. $< f$) in $\Omega^+(v) \cup \Omega^-(v)$ in the weak sense;
- (ii) If $x_0 \in F(v)$, then

$$|\nabla_A v^+(x_0)|^2 - |\nabla_A v^-(x_0)|^2 > 1 \quad (\text{resp. } |\nabla_A v^+(x_0)|^2 - |\nabla_A v^-(x_0)|^2 < 1).$$

We notice that, using the almost monotonicity formula in [MP], one can reproduce the proof of Theorem 4.5 in [CJK] to prove that viscosity solutions to (1.1) are locally Lipschitz continuous.

Our main Theorem is a “flatness implies regularity” result. Here, a constant depending (possibly) on $n, Lip(u), \lambda, \Lambda, [a_{ij}]_{C^{0,\bar{\gamma}}}, \|f\|_{L^\infty}$, is called universal.

Theorem 1.4 (Flatness implies $C^{1,\gamma}$). *Let u be a viscosity solution to (1.1) in B_1 . There exists a universal constant $\bar{\delta} > 0$ such that, if*

$$\{x_n \leq -\delta\} \subset B_1 \cap \{u^+(x) = 0\} \subset \{x_n \leq \delta\},$$

with $0 \leq \delta \leq \bar{\delta}$, then $F(u)$ is $C^{1,\gamma}$ in $B_{1/2}$ for some universal $\gamma \in (0, 1)$.

The strategy to prove Theorem 1.4 follows the lines of our work [DFS1]. The key tools are a Harnack type inequality and an improvement of flatness lemma which allow to linearize the problem into a standard transmission problem.

Next, a “Lipschitz implies regularity” result.

Theorem 1.5 (Lipschitz implies $C^{1,\gamma}$). *Let u be a viscosity solution to (1.1) in B_1 . If $F(u)$ is Lipschitz in B_1 , then $F(u)$ is $C^{1,\gamma}$ in $B_{1/2}$ for some universal $\gamma \in (0, 1)$.*

Theorem 1.5 follows from our flatness result via a blow-up argument and the regularity result in [C1] for the homogeneous problem when $A \equiv I$.

Actually, exploiting the variational nature of the free boundary condition, we can use a Weiss type monotonicity formula [W], which together with the monotonicity formula in [ACF] provides a new proof of the regularity result for the homogeneous problem and the Laplace operator. A similar strategy has been used in [DS].

We remark however, that for general free boundary conditions one has to rely on the result in [C1].

A consequence of our flatness theorem is a regularity result for the minimal Perron solution u , constructed in [DFS3]. We recall that in [DFS3] we prove that u is Lipschitz continuous with non-degenerate positive part and the free boundary $F(u)$ has finite $(n - 1)$ dimensional Hausdorff measure. Moreover, for c, r_0 universal, $r < r_0$, we have

$$\mathcal{H}^{n-1}(F(u) \cap B_r(x)) \leq cr^{n-1}, \text{ for all } x \in F(u),$$

and, denoting by $F^*(u)$ the reduced free boundary,

$$\mathcal{H}^{n-1}(F^*(u) \cap B_r(x)) \geq cr^{n-1}, \quad \mathcal{H}^{n-1}(F(u) \setminus F^*(u)) = 0.$$

From Theorem 1.4 we deduce the following result.

Theorem 1.6. *Let u be the Perron solution. In a neighborhood of every $x_0 \in F^*(u)$, $F(u)$ is a $C^{1,\gamma}$ surface.*

Important questions remain open as further regularity results, that we will consider in a forthcoming paper, and the analysis of the singular points of $F(u) \setminus F^*(u)$.

The paper is organized as follows. In Section 2 we prove a non-degeneracy property which allows us to reduce Theorem 1.4 to a normalized form. Sections 3 and 4 are devoted to the proof of the Harnack inequality and the improvement of flatness lemma in the non-degenerate and degenerate case respectively. In Section 5 we exhibit a new proof of the classical result in [C1]. Section 6 deals with Perron's solutions and Theorem 1.6. Finally, in Section 7 we apply our results to the Prandtl-Batchelor classical model in hydrodynamics.

2. NON-DEGENERACY

In this section we prove a non-degeneracy property which together with compactness arguments allows us to reduce our main Theorem 1.4 to a normalized form.

Denote by U_β the one-dimensional function,

$$U_\beta(t) = \alpha t^+ - \beta t^-, \quad \beta \geq 0, \quad \alpha = \sqrt{1 + \beta^2},$$

where

$$t^+ = \max\{t, 0\}, \quad t^- = -\min\{t, 0\}.$$

Then $U_\beta(x) = U_\beta(x_n)$ is the so-called two-plane solution to (1.1) when $A \equiv I$ and $f \equiv 0$.

Below, is our non-degeneracy result.

Lemma 2.1. *Let u be a solution to (1.1) in B_2 with $\text{Lip}(u) \leq L$ and $\|f\|_{L^\infty} \leq L$. If*

$$\{x_n \leq g(x') - \delta\} \subset \{u^+ = 0\} \subset \{x_n \leq g(x') + \delta\},$$

with g a Lipschitz function, $Lip(g) \leq L, g(0) = 0$, then

$$u(x) \geq c_0(x_n - g(x')), \quad x \in \{x_n \geq g(x') + 2\delta\} \cap B_{\rho_0},$$

for some $c_0, \rho_0 > 0$ depending on n, L, λ, Λ as long as $\delta \leq c_0$.

Proof. All constants in this proof will depend on n, L, λ, Λ .

It suffices to show that our statement holds for $\{x_n \geq g(x') + C\delta\}$ for a possibly large constant C . Then one can apply Harnack inequality to obtain the full statement.

We prove the statement above at $x = de_n$ (recall that $g(0) = 0$). Precisely, we want to show that

$$u(de_n) \geq c_0 d, \quad d \geq C\delta.$$

After rescaling, we reduce to proving that

$$u(e_n) \geq c_0$$

as long as $\delta \leq 1/C$, and $\|f\|_\infty$ is sufficiently small. For $t \geq 0$, set

$$\Omega_t := (B_2 \setminus \bar{B}_1)(-te_n).$$

Solve,

$$\begin{cases} \mathcal{L}w_t = -1 & \text{in } \Omega_t, \\ w_t = 0 & \text{on } \partial B_1(-te_n), \\ w_t = 1 & \text{on } \partial B_2(-te_n). \end{cases}$$

Extend $w_t = 0$ in $B_1(-te_n)$. By $C^{1,\bar{\gamma}}$ estimates and L^∞ estimates (see [GT]),

$$|\nabla_A w_t| \leq C(n, \lambda, \Lambda).$$

Hence, set

$$h_t := \frac{1}{2C} w_t,$$

we have that

$$|\nabla_A h_t^+|^2 - |\nabla_A h_t^-|^2 = |\nabla_A h_t^+|^2 < 1, \quad \text{on } F(h_t).$$

In this way w_t is a supersolution of our free boundary problem, as long as $\|f\|_\infty$ is small enough.

From our flatness assumption for $t = C(L) > 0$ sufficiently large (depending on the Lipschitz constant of g), h_t is strictly above u . We decrease t and let \bar{t} be the first t such that h_t touches u by above in $\Omega_{\bar{t}}$. Since $h_{\bar{t}}$ is a strict supersolution in $\Omega_{\bar{t}}$ the touching point z can occur only on the level set $\eta = \frac{1}{2C}$ in the positive phase of u . Otherwise, as usual we would get a contradiction with the free boundary condition by the Hopf maximum principle and the strong maximum principle. In addition $|z| \leq C' = C'(L)$, since u is Lipschitz continuous, $0 < u(z) = \eta \leq Ld(z, F(u))$, that is a full ball around z of radius η/L is contained in the positive phase of u . Thus, for $\bar{\delta}$ small depending on η, L we have that $B_{\eta/2L}(z) \subset \{x_n \geq g(x') + 2\bar{\delta}\}$. Since $x_n = g(x') + 2\bar{\delta}$ is Lipschitz we can connect e_n and z with a chain of intersecting balls included in the positive side of u with radii comparable to $\eta/2L$. The number of balls depends on L . Then we can apply Harnack inequality and obtain

$$u(e_n) \geq cu(z) = c_0,$$

as desired. \square

Following the argument in Section 2 [DFS1], Theorem 1.4 reduces to the following theorem (via a compactness argument.)

Theorem 2.2. *Let u be a solution to (1.1) in B_1 with $\text{Lip}(u) \leq L$. There exists a universal constant $\bar{\varepsilon} > 0$ such that, if*

$$(2.1) \quad \|u - U_\beta\|_{L^\infty(B_1)} \leq \bar{\varepsilon} \quad \text{for some } 0 \leq \beta \leq L,$$

and

$$\{x_n \leq -\bar{\varepsilon}\} \subset B_1 \cap \{u^+(x) = 0\} \subset \{x_n \leq \bar{\varepsilon}\},$$

and

$$[a_{ij}]_{C^{0,\gamma}(B_1)} \leq \bar{\varepsilon}, \quad \|f\|_{L^\infty(B_1)} \leq \bar{\varepsilon},$$

then $F(u)$ is $C^{1,\gamma}$ in $B_{1/2}$.

The proof of Theorem 2.2 follows verbatim the proof of Theorem 2.8 in [DFS1], once we have established the three key tools: the Harnack inequality, the improvement of flatness lemma, and the dichotomy lemma. Below we provide the proof of the dichotomy lemma, which differs from the case $A = I$ only slightly. The Harnack inequality and the improvement of flatness lemma are presented in the next two sections.

Lemma 2.3. *Let u solve (1.1) in B_2 with*

$$\|A - I\|_{C^{0,\gamma}} \leq \varepsilon^2, \quad \|f\|_{L^\infty(B_1)} \leq \varepsilon^4$$

and satisfy

$$(2.2) \quad \begin{aligned} U_0(x_n - \varepsilon) &\leq u^+(x) \leq U_0(x_n + \varepsilon) \quad \text{in } B_1, \quad 0 \in F(u), \\ \|u^-\|_{L^\infty(B_2)} &\leq \bar{C}\varepsilon^2, \quad \|u^-\|_{L^\infty(B_1)} > \varepsilon^2, \end{aligned}$$

for a universal constant \bar{C} . If $\varepsilon \leq \varepsilon_2$ universal, then the rescaling

$$u_\varepsilon(x) = \varepsilon^{-1/2} u(\varepsilon^{1/2} x)$$

satisfies in B_1

$$U_{\beta'}(x_n - C'\varepsilon^{1/2}) \leq u_\varepsilon(x) \leq U_{\beta'}(x_n + C'\varepsilon^{1/2})$$

with $\beta' \sim \varepsilon^2$ and $C' > 0$ depending on \bar{C} .

Proof. For notational simplicity we set

$$v = \frac{u^-}{\varepsilon^2}.$$

From our assumptions we can deduce that

$$F(v) \subset \{-\varepsilon \leq x_n \leq \varepsilon\},$$

$$(2.3) \quad v \geq 0 \quad \text{in } B_2 \cap \{x_n \leq -\varepsilon\}, \quad v \equiv 0 \quad \text{in } B_2 \cap \{x_n > \varepsilon\}.$$

Also,

$$|\mathcal{L}v| \leq \varepsilon^2, \quad \text{in } B_2 \cap \{x_n < -\varepsilon\},$$

and

$$(2.4) \quad 0 \leq v \leq \bar{C} \quad \text{on } \partial B_2,$$

$$(2.5) \quad v(\bar{x}) > 1 \quad \text{at some point } \bar{x} \text{ in } B_1.$$

Thus, using comparison with the function \bar{v} such that

$$\mathcal{L}\bar{v} = -\varepsilon^2 \quad \text{in } D := B_2 \cap \{x_n < \varepsilon\} \text{ and } \bar{v} = v \text{ on } \partial D$$

we obtain that for some $k > 0$ universal

$$(2.6) \quad v \leq k|x_n - \varepsilon|, \quad \text{in } B_1.$$

This fact forces the point \bar{x} in (2.5) to belong to $B_1 \cap \{x_n < -\varepsilon\}$ at a fixed distance δ from $x_n = -\varepsilon$.

Now, let w be the solution to $\mathcal{L}w = 0$ in $B_1 \cap \{x_n < -\varepsilon\}$ such that

$$w = 0 \quad \text{on } B_1 \cap \{x_n = -\varepsilon\}, \quad w = v \quad \text{on } \partial B_1 \cap \{x_n \leq -\varepsilon\}.$$

We conclude that

$$(2.7) \quad |w - v| \leq c\varepsilon \quad \text{in } B_1 \cap \{x_n < -\varepsilon\}.$$

In particular this is true at \bar{x} which forces

$$(2.8) \quad w(\bar{x}) \geq 1/2.$$

Furthermore, let \tilde{w} be harmonic in $B_{9/10} \cap \{x_n < -\varepsilon\}$, with boundary data w . By expanding \tilde{w} around $(0, -\varepsilon)$ we then obtain, say in $B_{3/4} \cap \{x_n \leq -\varepsilon\}$

$$|\tilde{w} - a|x_n + \varepsilon|| \leq C|x|^2 + C\varepsilon.$$

Moreover, since w is Lipschitz, then in $B_{3/4} \cap \{x_n \leq -\varepsilon\}$

$$|w - \tilde{w}| \leq C\varepsilon^2.$$

These last two inequalities combined with (2.7) give that

$$|v - a|x_n + \varepsilon|| \leq C\varepsilon, \quad \text{in } B_{\varepsilon^{1/2}} \cap \{x_n \leq -\varepsilon\}.$$

In view of (2.8) and the fact that \bar{x} occurs at a fixed distance from $\{x_n = -\varepsilon\}$ we deduce from Hopf lemma that

$$a \geq c > 0$$

with c universal. In conclusion (see (2.6))

$$|u^- - b\varepsilon^2|x_n + \varepsilon|| \leq C\varepsilon^3, \quad \text{in } B_{\varepsilon^{1/2}} \cap \{x_n \leq -\varepsilon\}, \quad u^- \leq b\varepsilon^2|x_n - \varepsilon|, \quad \text{in } B_1$$

with b comparable to a universal constant.

Combining the two inequalities above and the assumption (2.2) we conclude that in $B_{\varepsilon^{1/2}}$

$$(x_n - \varepsilon)^+ - b\varepsilon^2(x_n - C\varepsilon)^- \leq u(x) \leq (x_n + \varepsilon)^+ - b\varepsilon^2(x_n + C\varepsilon)^-$$

with $C > 0$ universal and b larger than a universal constant. Rescaling, we obtain that in B_1

$$(x_n - \varepsilon^{1/2})^+ - \beta'(x_n - C\varepsilon^{1/2})^- \leq u_\varepsilon(x) \leq (x_n + \varepsilon^{1/2})^+ - \beta'(x_n + C\varepsilon^{1/2})^-$$

with $\beta' \sim \varepsilon^2$. We finally need to check that this implies the desired conclusion in B_1 :

$$\alpha'(x_n - C\varepsilon^{1/2})^+ - \beta'(x_n - C\varepsilon^{1/2})^- \leq u_\varepsilon(x) \leq \alpha'(x_n + C\varepsilon^{1/2})^+ - \beta'(x_n + C\varepsilon^{1/2})^-$$

with $(\alpha')^2 = 1 + (\beta')^2 \sim 1 + \varepsilon^4$. This clearly holds in B_1 for ε small, say by possibly enlarging C so that $C \geq 2$. \square

3. NON-DEGENERATE CASE

In this section we prove the Harnack inequality and the improvement of flatness lemma in the so-called non-degenerate case. In this case our solution u is trapped between two translations of a “true” two-plane solution U_β that is ($L = \text{Lip}(u)$)

$$0 < \beta \leq L.$$

3.1. Harnack inequality. We start with the Harnack Inequality.

Theorem 3.1 (Harnack inequality). *There exists a universal constant $\bar{\varepsilon}$, such that if u satisfies at some point $x_0 \in B_2$*

$$(3.1) \quad U_\beta(x_n + a_0) \leq u(x) \leq U_\beta(x_n + b_0) \quad \text{in } B_r(x_0) \subset B_2,$$

with

$$(3.2) \quad \|f\|_{L^\infty(B_1)} \leq \varepsilon^2 \beta, \quad \|A - I\|_{C^{0,\bar{\gamma}}} \leq \varepsilon^2,$$

and

$$b_0 - a_0 \leq \varepsilon r,$$

for some $\varepsilon \leq \bar{\varepsilon}$, then

$$U_\beta(x_n + a_1) \leq u(x) \leq U_\beta(x_n + b_1) \quad \text{in } B_{r/20}(x_0),$$

with

$$a_0 \leq a_1 \leq b_1 \leq b_0, \quad b_1 - a_1 \leq (1 - c)\varepsilon r,$$

and $0 < c < 1$ universal.

We deduce the following Corollary for the oscillation of u , i.e.,

$$\tilde{u}_\varepsilon(x) = \begin{cases} \frac{u(x) - \alpha x_n}{\alpha \varepsilon} & \text{in } B_2^+(u) \cup F(u) \\ \frac{u(x) - \beta x_n}{\beta \varepsilon} & \text{in } B_2^-(u). \end{cases}$$

Corollary 3.2. *Let u be as in Theorem 3.1 satisfying (3.1) for $r = 1$. Then in $B_1(x_0)$ \tilde{u}_ε has a Hölder modulus of continuity at x_0 , outside the ball of radius $\varepsilon/\bar{\varepsilon}$, i.e for all $x \in B_1(x_0)$, with $|x - x_0| \geq \varepsilon/\bar{\varepsilon}$*

$$|\tilde{u}_\varepsilon(x) - \tilde{u}_\varepsilon(x_0)| \leq C|x - x_0|^\gamma.$$

The proof of the Harnack inequality follows from the next lemma (see [DFS1] for details).

Lemma 3.3. *There exists a universal constant $\bar{\varepsilon} > 0$ such that if (3.2) holds for $0 < \varepsilon < \bar{\varepsilon}$, and u satisfies*

$$u(x) \geq U_\beta(x), \quad \text{in } B_1$$

and at $\bar{x} = \frac{1}{5}e_n$

$$(3.3) \quad u(\bar{x}) \geq U_\beta(\bar{x}_n + \varepsilon),$$

then

$$(3.4) \quad u(x) \geq U_\beta(x_n + c\varepsilon), \quad \text{in } \bar{B}_{1/2},$$

for some $0 < c < 1$ universal. Analogously, if

$$u(x) \leq U_\beta(x), \quad \text{in } B_1$$

and

$$u(\bar{x}) \leq U_\beta(\bar{x}_n - \varepsilon),$$

then

$$u(x) \leq U_\beta(x_n - c\varepsilon), \quad \text{in } \bar{B}_{1/2}.$$

Proof. We prove the first statement. The proof of the second statement is similar. For notational simplicity we drop the sub-index β from U_β .

Since $x_n > 0$ in $B_{1/10}(\bar{x})$ and $u \geq U$ in B_1 we get

$$B_{1/10}(\bar{x}) \subset B_1^+(u).$$

Thus $u - U \geq 0$ and solves $\mathcal{L}(u - U) = f - \mathcal{L}U$ in $B_{1/10}(\bar{x})$. By Harnack inequality we obtain

$$(3.5) \quad u(x) - U(x) \geq c(u(\bar{x}) - U(\bar{x})) - C(\|f\|_{L^\infty} + \|(A - I)\nabla U\|_{C^{0,\bar{\gamma}}}) \quad \text{in } \bar{B}_{1/20}(\bar{x}).$$

From the assumptions (3.2) and (3.3) we conclude that (for ε small enough)

$$(3.6) \quad u - U \geq \alpha c\varepsilon - C\alpha\varepsilon^2 \geq \alpha c_0\varepsilon \quad \text{in } \bar{B}_{1/20}(\bar{x}).$$

This is the desired statement (3.3) in the ball $B_{1/20}(\bar{x})$. We now work in annuli

$$D_r := B_r(\bar{x}) \setminus \bar{B}_{1/20}(\bar{x}).$$

Let

$$(3.7) \quad w = c(|x - \bar{x}|^{-\eta} - (3/4)^{-\eta}), \quad x \in \bar{D}_{7/8},$$

with c such that

$$w = 1 \quad \text{on } \partial B_{1/20}(\bar{x}),$$

and η fixed larger than $n - 2$, so that

$$(3.8) \quad \Delta w \geq k(\eta, n) = k(n) > 0, \quad \text{on } D_{7/8}.$$

Notice that w becomes negative outside $B_{3/4}(\bar{x})$.

Set $\bar{w} = 1 - w$ and for $t \geq 0$,

$$v_t(x) = U(x_n - \varepsilon c_0 \bar{w}(x) + t\varepsilon), \quad x \in \bar{D}_{7/8}.$$

Then,

$$v_0(x) = U(x_n - \varepsilon c_0 \bar{w}(x)) \leq U(x) \leq u(x) \quad x \in \bar{D}_{7/8}.$$

In particular

$$(3.9) \quad \{v_0 > 0\} \subset \{u > 0\}.$$

Let \bar{t} be the largest $t \geq 0$ such that

$$(3.10) \quad \{v_t > 0\} \subset \{u > 0\}.$$

For any $t \leq \bar{t}$, call

$$D_{r,t}^+ = \{v_t > 0\} \cap D_r, D_{r,t}^- = \{v_t < 0\} \cap D_r.$$

Let ϕ_t^\pm be the solution to

$$(3.11) \quad \begin{cases} \mathcal{L}\phi_t^\pm = -\operatorname{div}((A - I)\nabla v_t) & \text{in } D_{7/8,t}^\pm \\ \phi_t^\pm = 0 & \text{on } \partial D_{7/8,t}^\pm. \end{cases}$$

By assumption (3.2) and the boundary regularity estimates for divergence form equations (see [GT]) we get

$$(3.12) \quad \|\phi_t^+\|_{C^{1,\bar{\gamma}}} \leq C\alpha\varepsilon^2, \quad \text{in } \overline{D_{6/7,t}^+}, \quad \|\phi_t^-\|_{C^{1,\bar{\gamma}}} \leq C\beta\varepsilon^2, \quad \text{in } \overline{D_{6/7,t}^-}$$

and by L^∞ estimates (see [GT])

$$(3.13) \quad \|\phi_t^+\|_{L^\infty} \leq C\alpha\varepsilon^2, \quad \text{in } \overline{D_{7/8,t}^+}, \quad \|\phi_t^-\|_{L^\infty} \leq C\beta\varepsilon^2, \quad \text{in } \overline{D_{7/8,t}^-}.$$

Call

$$\phi_t = \begin{cases} \phi_t^+ & \text{in } \overline{D_{7/8,t}^+} \\ \phi_t^- & \text{in } \overline{D_{7/8,t}^-} \end{cases}$$

Now set,

$$\psi_t = v_t + \phi_t.$$

Since w_n is bounded in the annulus $D_{7/8}$, we easily obtain that for ε small enough

$$(v_t)_n \geq \alpha/2 \quad \text{in } D_{7/8,t}^+ \quad (v_t)_n \geq \beta/2 \quad \text{in } D_{7/8,t}^-.$$

Thus, from the estimates above we conclude that

$$(\psi_t)_n > 0 \quad \text{in } \overline{D_{6/7,t}^+} \cup \overline{D_{6/7,t}^-}.$$

Hence, since $F(\psi_t)$ is a graph in the e_n direction (ε small), we get that

$$\{\psi_t > 0\} \cap D_{6/7} = \{v_t > 0\} \cap D_{6/7} = D_{6/7,t}^+,$$

$$(3.14) \quad \{\psi_t < 0\} \cap D_{6/7} = \{v_t < 0\} \cap D_{6/7} = D_{6/7,t}^-,$$

$$(3.15) \quad F(\psi_t) \cap D_{6/7} = F(v_t) \cap D_{6/7}.$$

Moreover, in view of (3.8), ψ_t solves

$$(3.16) \quad \mathcal{L}\psi_t = \Delta v_t \geq \varepsilon \beta c_0 k(n) \quad \text{in } D_{7/8,t}^+ \cup D_{7/8,t}^-.$$

From (3.10), (3.16) and assumption (3.2) we have

$$\mathcal{L}\psi_t > \mathcal{L}u \quad \text{in } D_{7/8,t}^+.$$

If $t \leq \min\{c_0, \bar{t}\}$, using (3.6) and the fact that $u \geq U$ we obtain that

$$\psi_t = v_t \leq u \quad \text{on } \partial D_{7/8,t}^+.$$

Thus, by the maximum principle

$$\psi_t \leq u \quad \text{in } D_{7/8,t}^+.$$

In particular,

$$(3.17) \quad \mathcal{L}\psi_t > f, \quad \psi_t \leq u \quad \text{in } \{\psi_t > 0\} \cap D_{6/7}.$$

Analogously,

$$\mathcal{L}\psi_t > \mathcal{L}u \quad \text{in } \{u < 0\} \cap D_{7/8,t}^-,$$

and using (3.14)

$$\psi_t \leq u \quad \text{on } F(u) \cap D_{6/7,t}^-.$$

Moreover, since $u \geq U$, using the definition of v_t and the fact that $w < -\tilde{c} < 0$ outside $B_{6/7}(\bar{x})$, we have that

$$(3.18) \quad v_t - u \leq -c\beta\varepsilon, \quad \text{in } (\overline{D_{7/8,t}^-} \setminus D_{6/7}).$$

Thus, from the L^∞ estimates (3.13), we obtain that (for ε small enough)

$$\psi_t < u \quad \text{in } \overline{D_{7/8,t}^-} \setminus D_{6/7}.$$

Now, by the maximum principle,

$$\psi_t \leq u, \quad \text{in } \{u < 0\} \cap D_{6/7,t}^-.$$

In particular,

$$(3.19) \quad \mathcal{L}\psi_t > f, \quad \psi_t \leq u, \quad \text{in } \{\psi_t < 0\} \cap D_{6/7}.$$

On the other hand, ψ_t satisfies

$$|\nabla_A \psi_t^+|^2 - |\nabla_A \psi_t^-|^2 > 1 \quad \text{on } F(\psi_t) \cap D_{6/7}.$$

Indeed, by assumption (3.2)

$$|\nabla_A \psi_t^+|^2 > (1 - \varepsilon^2) |\nabla \psi_t^+|^2$$

and

$$|\nabla_A \psi_t^-|^2 \leq (1 + \varepsilon^2) |\nabla \psi_t^-|^2.$$

Furthermore, by the $C^{1,\bar{\gamma}}$ estimate (3.12) and assumption (3.2), we have that on $F(\psi_t) \cap D_{6/7}$, (recall α, β are bounded)

$$|\nabla \psi_t^+|^2 \geq (1 - \varepsilon^2) |\nabla v_t^+|^2 - C' \varepsilon^2, \quad |\nabla \psi_t^-|^2 \leq (1 + \varepsilon^2) |\nabla v_t^-|^2 + C'' \varepsilon^2,$$

with,

$$|\nabla v_t^+|^2 = \alpha^2 (1 + \varepsilon^2 c_0^2 |\nabla w|^2 + 2\varepsilon c_0 w_n), \quad |\nabla v_t^-|^2 = \beta^2 (1 + \varepsilon^2 c_0^2 |\nabla w|^2 + 2\varepsilon c_0 w_n).$$

Hence, for \bar{C} universal,

$$|\nabla_A \psi_t^+|^2 - |\nabla_A \psi_t^-|^2 \geq (1 + 2\varepsilon c_0 w_n) - \bar{C} \varepsilon^2 \quad \text{on } F(\psi_t) \cap D_{6/7}.$$

Using that $w_n \geq c > 0$ on $F(\psi_t) \cap D_{6/7}$ we obtain the desired claim by choosing ε small enough.

In conclusion, ψ_t is a strict subsolution in $D_{6/7}$ which lies below u , if $t \leq \min\{\bar{t}, c_0\}$.

However, if $\bar{t} \leq c_0$, then $F(\psi_{\bar{t}})$ touches $F(u)$ in $D_{6/7}$, which is a contradiction. Indeed, for $t \leq c_0$, $v_t < u$ on $(\bar{B}_{7/8}(\bar{x}) \setminus B_{6/7}(\bar{x})) \cup \partial B_{1/20}(\bar{x})$ (see (3.6), (3.18) and its analogue in $\bar{D}_{7/8}^+ \setminus D_{6/7}$.) Since \bar{t} is the largest $t \geq 0$ for which the inclusion (3.10) holds, we deduce that $F(v_{\bar{t}}) \cap F(u) \neq \emptyset$ in $D_{6/7}$. It follows from (3.15) that $F(\psi_{\bar{t}}) \cap F(u) \neq \emptyset$ in $D_{6/7}$, as desired.

Thus $\bar{t} > c_0$. In particular, for $t = c_0$,

$$\psi_{c_0} \leq u \quad \text{in } D_{6/7}.$$

Then we get the desired statement. Indeed, by the L^∞ estimate we obtain in $(B_{1/2} \cap \{\psi_{c_0} > 0\}) \setminus B_{1/20}(\bar{x}) \subset\subset D_{6/7}$

$$u(x) \geq \psi_{c_0}(x) \geq -C\alpha\varepsilon^2 + U(x_n + c_0\varepsilon w) \geq U(x_n + c\varepsilon)$$

and analogously, in $(B_{1/2} \cap \{\psi_{c_0} \leq 0\}) \setminus B_{1/20}(\bar{x}) \subset\subset D_{6/7}$

$$u(x) \geq \psi_{c_0}(x) \geq -C\beta\varepsilon^2 + U(x_n + c_0\varepsilon w) \geq U(x_n + c\varepsilon)$$

with c universal. Above we used that $w \geq \bar{c} > 0$ on $B_{1/2}$, and ε is chosen sufficiently small. \square

3.2. Improvement of flatness. We are now ready to prove the improvement of flatness lemma in the non-degenerate case.

Lemma 3.4 (Improvement of flatness). *Let u satisfy*

$$(3.20) \quad U_\beta(x_n - \varepsilon) \leq u(x) \leq U_\beta(x_n + \varepsilon) \quad \text{in } B_1, \quad 0 \in F(u),$$

with

$$(3.21) \quad \|A - I\|_{C^{0,\bar{\gamma}}} \leq \varepsilon^2, \quad \|f\|_{L^\infty(B_1)} \leq \varepsilon^2 \beta.$$

If $0 < r \leq r_0$ for r_0 universal, and $0 < \varepsilon \leq \varepsilon_0$ for some ε_0 depending on r , then

$$(3.22) \quad U_{\beta'}(x \cdot \nu_1 - r \frac{\varepsilon}{2}) \leq u(x) \leq U_{\beta'}(x \cdot \nu_1 + r \frac{\varepsilon}{2}) \quad \text{in } B_r,$$

with $|\nu_1| = 1$, $|\nu_1 - e_n| \leq \tilde{C}\varepsilon$, and $|\beta - \beta'| \leq \tilde{C}\beta\varepsilon$ for a universal constant \tilde{C} .

Proof. The proof of this Lemma is divided into 3 steps.

Step 1 – Compactness. Fix $r \leq r_0$ with r_0 universal (made precise in Step 3). Assume by contradiction that we can find a sequence $\varepsilon_k \rightarrow 0$ and a sequence u_k of solutions to

$$\begin{cases} \mathcal{L}_k u_k := \operatorname{div}(A_k \nabla u_k) = f_k & \text{in } B_1^+(u_k) \cup B_1^-(u_k) \\ |\nabla_{A_k} u_k^+|^2 - |\nabla_{A_k} u_k^-|^2 = 1 & \text{on } F(u_k) \end{cases}$$

with

$$(3.23) \quad \|f_k\|_{L^\infty} \leq \beta_k \varepsilon_k^2, \quad \|A_k - I\|_{C^{0,\bar{\gamma}}} \leq \varepsilon_k^2$$

such that

$$(3.24) \quad U_{\beta_k}(x_n - \varepsilon_k) \leq u_k(x) \leq U_{\beta_k}(x_n + \varepsilon_k) \quad \text{for } x \in B_1, \quad 0 \in F(u_k),$$

with $L \geq \beta_k > 0$, but u_k does not satisfy the conclusion (3.22) of the lemma.

Set $(\alpha_k^2 = 1 + \beta_k^2)$,

$$\tilde{u}_k(x) = \begin{cases} \frac{u_k(x) - \alpha_k x_n}{\alpha_k \varepsilon_k}, & x \in B_1^+(u_k) \cup F(u_k) \\ \frac{u_k(x) - \beta_k x_n}{\beta_k \varepsilon_k}, & x \in B_1^-(u_k). \end{cases}$$

Then (3.24) gives,

$$(3.25) \quad -1 \leq \tilde{u}_k(x) \leq 1 \quad \text{for } x \in B_1.$$

From Corollary 3.2, it follows that the function \tilde{u}_k satisfies

$$(3.26) \quad |\tilde{u}_k(x) - \tilde{u}_k(y)| \leq C|x - y|^\gamma,$$

for C universal and

$$|x - y| \geq \varepsilon_k / \bar{\varepsilon}, \quad x, y \in B_{1/2}.$$

From (3.24) it clearly follows that $F(u_k)$ converges to $B_1 \cap \{x_n = 0\}$ in the Hausdorff distance. This fact and (3.26) together with Ascoli-Arzelà give that as $\varepsilon_k \rightarrow 0$ the graphs of the \tilde{u}_k converge (up to a subsequence) in the Hausdorff distance to the graph of a Hölder continuous function \tilde{u} over $B_{1/2}$. Also, up to a subsequence

$$\beta_k \rightarrow \tilde{\beta} \geq 0$$

and hence

$$\alpha_k \rightarrow \tilde{\alpha} = \sqrt{1 + \tilde{\beta}^2}.$$

Step 2 – Limiting Solution. We show that \tilde{u} solves the linearized problem

$$(3.27) \quad \begin{cases} \Delta \tilde{u} = 0 & \text{in } B_{1/2} \cap \{x_n \neq 0\}, \\ \tilde{\alpha}^2(\tilde{u}_n)^+ - \tilde{\beta}^2(\tilde{u}_n)^- = 0 & \text{on } B_{1/2} \cap \{x_n = 0\}. \end{cases}$$

Since

$$\Delta u_k = f_k - \operatorname{div}((A_k - I)\nabla u_k) \quad \text{in } B_1^+(u_k) \cup B_1^-(u_k),$$

one easily deduces that \tilde{u} is harmonic in $B_{1/2} \cap \{x_n \neq 0\}$.

Next, we prove that \tilde{u} satisfies the boundary condition in (3.27) in the viscosity sense.

Assume by contradiction that there exists a function $\tilde{\phi}$ of the form

$$\tilde{\phi}(x) = M + px_n^+ - qx_n^- + BQ(x - y)$$

with

$$Q(x) = \frac{1}{2}[(n-1)x_n^2 - |x'|^2], \quad y = (y', 0), \quad M \in \mathbb{R}, B > 0$$

and

$$\tilde{\alpha}^2 p - \tilde{\beta}^2 q > 0,$$

which touches \tilde{u} strictly by below at a point $x_0 = (x'_0, 0) \in B_{1/2}$.

As in [DFS1], let

$$(3.28) \quad \Gamma(x) = \frac{1}{n-2}[(|x'|^2 + |x_n - 1|^2)^{\frac{2-n}{2}} - 1]$$

and let

$$(3.29) \quad \Gamma_k(x) = \frac{1}{B\varepsilon_k} \Gamma(B\varepsilon_k(x - y) + MB\varepsilon_k^2 e_n).$$

Now, call

$$\phi_k(x) = a_k \Gamma_k^+(x) - b_k \Gamma_k^-(x) + \alpha_k (d_k^+(x))^2 \varepsilon_k^{3/2} + \beta_k (d_k^-(x))^2 \varepsilon_k^{3/2}$$

where

$$a_k = \alpha_k(1 + \varepsilon_k p), \quad b_k = \beta_k(1 + \varepsilon_k q)$$

and $d_k(x)$ is the signed distance from x to $\partial B_{\frac{1}{B\varepsilon_k}}(y + e_n(\frac{1}{B\varepsilon_k} - M\varepsilon_k))$.

Now, call g_k^\pm the solution to

$$\begin{cases} \mathcal{L}_k g_k^\pm = -\operatorname{div}((A_k - I)\nabla \phi_k) & \text{in } B_1^\pm(\phi_k) \\ g_k = 0 & \text{on } F(\phi_k). \end{cases}$$

By $C^{1,\bar{\gamma}}$ and L^∞ estimates, using the first one of (3.21) and the formula for ϕ_k , we get

$$\|g_k^+\|_{C^{1,\bar{\gamma}}} \leq C(a_k + \alpha_k)\varepsilon_k^2 \quad \text{in } \overline{B_{7/8}^+}(\phi_k), \quad \|g_k^-\|_{C^{1,\bar{\gamma}}} \leq C(b_k + \beta_k)\varepsilon_k^2 \quad \text{in } \overline{B_{7/8}^-}(\phi_k),$$

and

$$\|g_k^+\|_{L^\infty} \leq C(a_k + \alpha_k)\varepsilon_k^2, \quad \text{in } \overline{B_1^+}(\phi_k), \quad \|g_k^-\|_{L^\infty} \leq C(b_k + \beta_k)\varepsilon_k^2, \quad \text{in } \overline{B_1^-}(\phi_k).$$

Set,

$$\gamma_k^\pm := \phi_k^\pm + g_k^\pm,$$

and

$$\tilde{\gamma}_k(x) = \begin{cases} \tilde{\phi}_k + \frac{g_k^+}{\alpha_k \varepsilon_k} = \frac{\phi_k(x) - \alpha_k x_n}{\alpha_k \varepsilon_k} + \frac{g_k^+}{\alpha_k \varepsilon_k}, & x \in B_1^+(\phi_k) \cup F(\phi_k) \\ \tilde{\phi}_k + \frac{g_k^-}{\beta_k \varepsilon_k} = \frac{\phi_k(x) - \beta_k x_n}{\beta_k \varepsilon_k} + \frac{g_k^-}{\beta_k \varepsilon_k} & x \in B_1^-(\phi_k). \end{cases}$$

As shown in [DFS1], $\tilde{\phi}_k$ converges uniformly to $\tilde{\phi}$ on $B_{1/2}$. Thus, from the L^∞ estimates, also $\tilde{\gamma}_k$ converges uniformly to $\tilde{\phi}$ on $B_{1/2}$.

Since \tilde{u}_k converges uniformly to \tilde{u} and $\tilde{\phi}$ touches \tilde{u} strictly by below at x_0 , we conclude that there exist a sequence of constants $c_k \rightarrow 0$ and of points $x_k \rightarrow x_0$ such that the function

$$\psi_k(x) = \gamma_k(\bar{x}), \quad \bar{x} = x + \varepsilon_k c_k e_n$$

touches u_k by below at x_k . We will get a contradiction by proving that ψ_k is a strict subsolution to our free boundary problem in $B_{7/8}$, that is

$$\begin{cases} \mathcal{L}_k \psi_k > \varepsilon_k^2 \beta_k \geq \|f_k\|_\infty, & \text{in } B_{7/8}^+(\psi_k) \cup B_{7/8}^-(\psi_k), \\ |\nabla_{A_k} \psi_k^+|^2 - |\nabla_{A_k} \psi_k^-|^2 > 1, & \text{on } F(\psi_k). \end{cases}$$

First, we show that

$$(3.30) \quad B_{7/8}^\pm(\gamma_k) = B_{7/8}^\pm(\phi_k), \quad F(\gamma_k) \cap B_{7/8} = F(\phi_k) \cap B_{7/8}.$$

To this aim, notice that for k large enough $\partial_n \Gamma_k^\pm \geq c > 0$ and $\partial_n (d_k^\pm)^2$ is bounded, thus

$$\begin{aligned} \partial_n \phi_k &\geq c a_k - C \alpha_k \varepsilon_k^{3/2} & \text{in } B_1^+(\phi_k), \\ \partial_n \phi_k &\geq c b_k - C \beta_k \varepsilon_k^{3/2} & \text{in } B_1^-(\phi_k). \end{aligned}$$

These inequalities combined with the $C^{1,\bar{\gamma}}$ estimates for g_k give that

$$\partial_n \gamma_k^\pm > 0 \quad \text{in } \overline{B_{7/8}}(\phi_k).$$

Since $F(\phi_k)$ is a graph in the e_n direction (for k large), we deduce the desired claim (3.30).

It is easily checked that away from the free boundary

$$\mathcal{L}_k \psi_k = \Delta \phi_k(\bar{x}) \geq \beta_k \varepsilon_k^{3/2} \Delta d_k^2(\bar{x})$$

and the first condition is satisfied for k large enough.

Finally, since on the zero level set $|\nabla \Gamma_k| = 1$ and $|\nabla d_k^2| = 0$ we have that

$$(\phi_k^+)_\nu(\bar{x}) = a_k^2, \quad (\phi_k^-)_\nu(\bar{x}) = b_k^2.$$

By the second equation in (3.23),

$$|\nabla_{A_k} \psi_k^+|^2 - |\nabla_{A_k} \psi_k^-|^2 \geq (1 - \varepsilon_k) |\nabla \psi_k^+|^2 - (1 + \varepsilon_k^2) |\nabla \psi_k^-|^2.$$

Moreover, using the $C^{1,\bar{\gamma}}$ estimates for g_k^\pm we get that

$$|\nabla \psi_k^+|^2 \geq (1 - \varepsilon_k^2)a_k^2 - C'\varepsilon_k^2, \quad |\nabla \psi_k^-|^2 \leq (1 + \varepsilon_k^2)b_k^2 + C''\varepsilon_k^2.$$

These, combined with the estimate above and the definition of a_k and b_k give that

$$|\nabla_{A_k} \psi_k^+|^2 - |\nabla_{A_k} \psi_k^-|^2 \geq 1 + (\alpha_k^2 p^2 - \beta_k^2 q^2)\varepsilon_k^2 + 2\varepsilon_k(\alpha_k p - \beta_k q) - C\varepsilon_k^2 > 1.$$

The last inequality holds for k large in view of the fact that

$$\tilde{\alpha}^2 p - \tilde{\beta}^2 q > 0.$$

Step 3 – Contradiction. This step follows as in [DFS1]. \square

4. DEGENERATE CASE

In this section we prove the Harnack inequality and the improvement of flatness lemma, in the so-called degenerate case. In this case, the negative part of u is negligible and the positive part is close to a one-plane solution (i.e. $\beta = 0$).

4.1. Harnack inequality. We start with the Harnack inequality.

Theorem 4.1 (Harnack inequality). *There exists a universal constant $\bar{\varepsilon}$, such that if u satisfies at some point $x_0 \in B_2$*

$$(4.1) \quad U_0(x_n + a_0) \leq u^+(x) \leq U_0(x_n + b_0) \quad \text{in } B_r(x_0) \subset B_2,$$

with

$$(4.2) \quad \|u^-\|_{L^\infty} \leq \varepsilon^2, \quad \|f\|_{L^\infty} \leq \varepsilon^4, \quad \|A - I\|_{C^{0,\gamma}} \leq \varepsilon^2$$

and

$$b_0 - a_0 \leq \varepsilon r,$$

for some $\varepsilon \leq \bar{\varepsilon}$, then

$$U_0(x_n + a_1) \leq u^+(x) \leq U_0(x_n + b_1) \quad \text{in } B_{r/20}(x_0),$$

with

$$a_0 \leq a_1 \leq b_1 \leq b_0, \quad b_1 - a_1 \leq (1 - c)\varepsilon r,$$

and $0 < c < 1$ universal.

We can argue as in the nondegenerate case and get the following result.

Corollary 4.2. *Let u be as in Theorem 4.1 satisfying (4.1) for $r = 1$. Then in $B_1(x_0)$*

$$\tilde{u}_\varepsilon := \frac{u^+(x) - x_n}{\varepsilon}$$

has a Hölder modulus of continuity at x_0 , outside the ball of radius $\varepsilon/\bar{\varepsilon}$, i.e for all $x \in B_1(x_0)$, with $|x - x_0| \geq \varepsilon/\bar{\varepsilon}$

$$|\tilde{u}_\varepsilon(x) - \tilde{u}_\varepsilon(x_0)| \leq C|x - x_0|^\gamma.$$

As before, the proof of the Harnack inequality can be deduced from the following lemma.

Lemma 4.3. *There exists a universal constant $\bar{\varepsilon} > 0$ such that if (4.2) holds and u satisfies*

$$u^+(x) \geq U_0(x), \quad \text{in } B_1$$

for some $\varepsilon \leq \bar{\varepsilon}$, and at $\bar{x} = \frac{1}{5}e_n$

$$(4.3) \quad u^+(\bar{x}) \geq U_0(\bar{x}_n + \varepsilon),$$

then

$$(4.4) \quad u^+(x) \geq U_0(x_n + c\varepsilon), \quad \text{in } \bar{B}_{1/2},$$

for some $0 < c < 1$ universal. Analogously, if

$$u^+(x) \leq U_0(x), \quad \text{in } B_1$$

and

$$u^+(\bar{x}) \leq U_0(\bar{x}_n - \varepsilon),$$

then

$$u^+(x) \leq U_0(x_n - c\varepsilon), \quad \text{in } \bar{B}_{1/2}.$$

Proof. We prove the first statement. We use the same notation as in Lemma 3.3.

Since $x_n > 0$ in $B_{1/10}(\bar{x})$ and $u^+ \geq U_0$ in B_1 we get

$$B_{1/10}(\bar{x}) \subset B_1^+(u).$$

Thus $u - x_n \geq 0$ and solves $\mathcal{L}(u - x_n) = f - \operatorname{div}((A - I)e_n)$ in $B_{1/10}(\bar{x})$ and we can apply Harnack inequality and the assumptions (4.2) and (4.3) to obtain that (for ε small enough)

$$(4.5) \quad u - x_n \geq c_0\varepsilon \quad \text{in } \bar{B}_{1/20}(\bar{x}).$$

Let w be as in the proof of Lemma 3.3 and $\bar{w} = 1 - w$. Set, for $t \geq 0$,

$$v_t(x) = (x_n - \varepsilon c_0 \bar{w} + t\varepsilon)^+ - \varepsilon^2 C_1 (x_n - \varepsilon c_0 \bar{w} + t\varepsilon)^-, \quad x \in \bar{B}_{3/4}(\bar{x}).$$

Here C_1 is a universal constant to be made precise later. We claim that

$$v_0(x) \leq u(x) \quad x \in \bar{B}_{3/4}(\bar{x}).$$

This is readily verified in the set where u is non-negative using that $u^+ \geq x_n^+$. To prove our claim in the set where u is negative we wish to use the following fact:

$$(4.6) \quad u^- \leq C x_n^- \varepsilon^2, \quad \text{in } B_{\frac{19}{20}}, \quad C \text{ universal.}$$

This estimate is easily obtained using that $\{u < 0\} \subset \{x_n < 0\}$, $\|u^-\|_\infty < \varepsilon^2$ and the comparison principle with the function z satisfying

$$\mathcal{L}z = -\varepsilon^4 \quad \text{in } B_1 \cap \{x_n < 0\}, \quad z = u^- \quad \text{on } \partial(B_1 \cap \{x_n < 0\}).$$

Thus our claim immediately follows from the Lipschitz continuity of z in $B_{19/20} \cap \{x_n < 0\}$, the fact that $u^- \leq z$ and that, for $x_n < 0$ and a suitable $C_1 > C$,

$$\varepsilon^2 C_1 (x_n - \varepsilon c_0 \bar{w}(x)) \leq C x_n \varepsilon^2.$$

Let \bar{t} be the largest $t \geq 0$ such that,

$$(4.7) \quad \{v_t > 0\} \subset \{u > 0\} \quad \text{in } \bar{D}_{7/8}.$$

From now on, the proof follows the lines of the non-degenerate case. Let ϕ_t^\pm and $D_{r,t}^\pm$ be as in (3.11), with $t \leq \bar{t}$.

Then, by assumption (4.2) and the boundary regularity estimates for divergence form equations we get

$$(4.8) \quad \|\phi_t^+\|_{C^{1,\bar{\gamma}}} \leq C\varepsilon^2, \quad \text{in } \overline{D_{6/7,t}^+} \quad \|\phi_t^-\|_{C^{1,\bar{\gamma}}} \leq C\varepsilon^4 \quad \text{in } \overline{D_{6/7,t}^-}$$

and by L^∞ estimates

$$(4.9) \quad \|\phi_t^+\|_{L^\infty} \leq C\varepsilon^2, \quad \text{in } \overline{D_{7/8,t}^+}, \quad \|\phi_t^-\|_{L^\infty} \leq C\varepsilon^4, \quad \text{in } \overline{D_{7/8,t}^-}.$$

Call

$$\phi_t = \begin{cases} \phi_t^+ \text{ in } \overline{D_{7/8,t}^+} \\ \phi_t^- \text{ in } \overline{D_{7/8,t}^-}. \end{cases}$$

Set

$$\psi_t = v_t + \phi_t.$$

Since w_n is bounded in the annulus $D_{7/8}$, we easily obtain that for ε small enough,

$$\begin{aligned} (v_t)_n &\geq c_2 > 0 && \text{in } \overline{D_{7/8,t}^+} \\ (v_t)_n &\geq c_3\varepsilon^3 > 0 && \text{in } \overline{D_{7/8,t}^-}. \end{aligned}$$

Thus, from the $C^{1,\bar{\gamma}}$ estimates above we conclude that

$$\begin{aligned} (\psi_t)_n &\geq c_4 > 0 && \text{in } \overline{D_{6/7,t}^+} \\ (\psi_t)_n &\geq c_5\varepsilon^3 > 0 && \text{in } \overline{D_{6/7,t}^-}. \end{aligned}$$

Hence, since $F(\psi_t)$ is a graph in the e_n direction for ε small, we get that

$$\{\psi_t > 0\} \cap \overline{D_{6/7}} = \{v_t > 0\} \cap \overline{D_{6/7}},$$

$$(4.10) \quad \{\psi_t < 0\} \cap \overline{D_{6/7}} = \{v_t < 0\} \cap \overline{D_{6/7}},$$

$$(4.11) \quad F(\psi_t) \cap \overline{D_{6/7}} = F(v_t) \cap \overline{D_{6/7}}.$$

Moreover, ψ_t solves

$$(4.12) \quad \mathcal{L}\psi_t = \Delta v_t \quad \text{in } D_{7/8,t}^+ \cup D_{7/8,t}^-,$$

and by assumption (4.2)

$$\Delta v_t \geq \varepsilon^3 c_0 k(n) > \varepsilon^4 \geq \|f\|_\infty, \quad \text{in } D_{7/8,t}^+ \cup D_{7/8,t}^-$$

for ε small enough.

Let $t \leq \min\{\bar{t}, c_0\}$. Since $u^+ \geq x_n^+$ and $w \leq -c < 0$ in $\overline{D_{7/8,t}^+} \setminus D_{6/7}$, we have

$$v_t(x) = x_n - c_0\varepsilon\bar{w} + t\varepsilon \leq x_n + c_0\varepsilon w \leq u - c\varepsilon.$$

Hence, by the L^∞ estimate (4.9) we have $\psi_t < u$ in $\overline{D_{7/8,t}^+} \setminus D_{6/7}$ for ε small.

Moreover, since $\mathcal{L}\psi_t \geq f$, the maximum principle gives $\psi_t \leq u$ in $\overline{D_{7/8,t}^+}$ (using also (4.5)).

In $D_{7/8,t}^- \setminus \overline{D_{6/7}} \cap \{u < 0\}$, using (4.6), since $\{u < 0\} \subset \{x_n < 0\}$,

$$v_t(x) - u = -\varepsilon^2 C_1 (x_n - c_0\varepsilon\bar{w} + t\varepsilon)^- + u^- \leq -c\varepsilon^3$$

if C_1 is chosen large enough. Hence, by the L^∞ estimates for ϕ_t , we have $\psi_t < u$ in $\overline{D_{7/8,t}^-} \setminus D_{6/7} \cap \{u < 0\}$ for ε small. Again by maximum principle we infer $\psi_t \leq u$, in $\{u < 0\} \cap D_{6/7,t}^-$.

In particular,

$$\mathcal{L}\psi_t > f, \quad \psi_{\bar{t}} \leq u, \quad \text{in } \{\psi_t < 0\} \cap \overline{D}_{6/7}$$

Summarizing: if $t \leq \min\{\bar{t}, c_0\}$ then $\psi_t \leq u$, in $\overline{D}_{6/7}$ and $v_{\bar{t}} < u$ in $\overline{D}_{7/8} \setminus D_{6/7}$ and on $\partial B_{1/20}(\bar{x})$ by (4.5).

On the other hand, using the $C^{1,\bar{\gamma}}$ estimates for ϕ_t^\pm and that on $F(v_t) \cap D_{7/8}$

$$|\nabla v_t^+|^2 = (1 + \varepsilon^2 c_0^2 |\nabla w|^2 + 2\varepsilon c_0 w_n), \quad |\nabla v_t^-|^2 = \varepsilon^4 C_1^2 (1 + \varepsilon^2 c_0^2 |\nabla w|^2 - 2\varepsilon c_0 w_n),$$

we conclude as in Lemma 3.3 that

$$|\nabla_A \psi_t^+|^2 - |\nabla_A \psi_t^-|^2 > 1 \quad \text{on } F(\psi_t) \cap \overline{D}_{6/7}.$$

We thus reach a contradiction as in the non-degenerate case, unless $\bar{t} > c_0$.

In particular,

$$(4.13) \quad \psi_{c_0} \leq u \quad \text{in } D_{6/7}$$

and we can write, by the L^∞ estimate for ϕ_{c_0} , in $B_{1/2} \subset \subset \overline{D}_{6/7}$

$$\begin{aligned} u^+(x) &\geq \psi_{c_0}^+(x) \geq -C\varepsilon^2 + (x_n - \varepsilon c_0 \psi + c_0 \varepsilon)^+ \\ &= -C\varepsilon^2 + (x_n + \varepsilon c_0 w)^+ \\ &\geq -C\varepsilon^2 + (x_n + \varepsilon \bar{c})^+ \end{aligned}$$

where we used that $w \geq c > 0$ on $B_{1/2}$. Since $u^+(x) \geq x_n^+$ we infer, if ε is small,

$$u^+(x) \geq (x_n + c\varepsilon)^+,$$

with c universal. \square

4.2. Improvement of flatness. We are now ready to prove the improvement of flatness lemma in the degenerate case.

Lemma 4.4. *Let u satisfy*

$$(4.14) \quad U_0(x_n - \varepsilon) \leq u^+(x) \leq U_0(x_n + \varepsilon) \quad \text{in } B_1, \quad 0 \in F(u),$$

with

$$\|f\|_{L^\infty(B_1)} \leq \varepsilon^4, \quad \|A - I\|_{C^{0,\bar{\gamma}}} \leq \varepsilon^2$$

and

$$\|u^-\|_{L^\infty(B_1)} \leq \varepsilon^2.$$

If $0 < r \leq r_1$ for r_1 universal, and $0 < \varepsilon \leq \varepsilon_1$ for some ε_1 depending on r , then

$$(4.15) \quad U_0(x \cdot \nu_1 - r \frac{\varepsilon}{2}) \leq u^+(x) \leq U_0(x \cdot \nu_1 + r \frac{\varepsilon}{2}) \quad \text{in } B_r,$$

with $|\nu_1| = 1$, $|\nu_1 - e_n| \leq C\varepsilon$ for a universal constant C .

Proof. We argue similarly as in the non-degenerate case.

Step 1 – Compactness. Fix $r \leq r_1$ with r_1 universal (made precise in Step 3). Assume by contradiction that we can find a sequence $\varepsilon_k \rightarrow 0$ and a sequence u_k of solutions to

$$\begin{cases} \mathcal{L}_k u_k := \operatorname{div}(A_k \nabla u_k) = f_k & \text{in } B_1^+(u_k) \cup B_1^-(u_k) \\ (u_k^+)_\nu^2 - (u_k^-)_\nu^2 = 1 & \text{on } F(u_k) \end{cases}$$

$$\|u_k^-\|_{L^\infty(B_1)} \leq \varepsilon_k^2$$

with

$$\|f_k\|_{L^\infty} \leq \varepsilon_k^4, \quad \|A_k - I\|_{C^{1,\bar{\gamma}}} \leq \varepsilon_k^2$$

such that

$$(4.16) \quad U_0(x_n - \varepsilon_k) \leq u_k^+(x) \leq U_0(x_n + \varepsilon_k) \quad \text{for } x \in B_1, 0 \in F(u_k),$$

but u_k does not satisfy the conclusion of the lemma.

Set

$$\tilde{u}_k(x) = \frac{u_k(x) - x_n}{\varepsilon_k}, \quad x \in B_1^+(u_k) \cup F(u_k)$$

Then (4.16) gives,

$$(4.17) \quad -1 \leq \tilde{u}_k(x) \leq 1 \quad \text{for } x \in B_1^+(u_k) \cup F(u_k).$$

As in the non-degenerate case, it follows from Corollary 4.2 that as $\varepsilon_k \rightarrow 0$ the graphs of the \tilde{u}_k converge (up to a subsequence) in the Hausdorff distance to the graph of a Hölder continuous function \tilde{u} over $B_{1/2} \cap \{x_n \geq 0\}$.

Step 2 – Limiting Solution. We now show that \tilde{u} solves the following Neumann problem

$$(4.18) \quad \begin{cases} \Delta \tilde{u} = 0 & \text{in } B_{1/2} \cap \{x_n > 0\}, \\ \partial_n \tilde{u} = 0 & \text{on } B_{1/2} \cap \{x_n = 0\}. \end{cases}$$

As before, the interior condition follows easily. Thus we focus on the boundary condition.

Let $\tilde{\phi}$ be a function of the form

$$\tilde{\phi}(x) = M + px_n + BQ(x - y)$$

with

$$Q(x) = \frac{1}{2}[(n-1)x_n^2 - |x'|^2], \quad y = (y', 0), \quad M \in \mathbb{R}, B > 0$$

and

$$p > 0.$$

Then we must show that $\tilde{\phi}$ cannot touch u strictly by below at a point $x_0 = (x'_0, 0) \in B_{1/2}$. Suppose that such a $\tilde{\phi}$ exists and let x_0 be the touching point.

Let Γ_k be as in the proof of the non-degenerate case (see (3.29)). Call

$$\phi_k(x) = a_k \Gamma_k^+(x) + (d_k^+(x))^2 \varepsilon_k^2, \quad a_k = (1 + \varepsilon_k p)$$

where $d_k(x)$ is the signed distance from x to $\partial B_{\frac{1}{B\varepsilon_k}}(y + e_n(\frac{1}{B\varepsilon_k} - M\varepsilon_k))$.

Now, call g_k the solution to

$$\begin{cases} \mathcal{L}_k g_k = -\operatorname{div}((A_k - I)\nabla \phi_k) & \text{in } B_1^+(\phi_k) \\ g_k = 0 & \text{on } \partial B_1^+(\phi_k) \end{cases}$$

extended by zero to $B_1^-(\phi_k)$

By $C^{1,\bar{\gamma}}$ and L^∞ estimates, using the first one of (3.21) and the formula for ϕ_k , we get

$$\begin{aligned} \|g_k\|_{C^{1,\bar{\gamma}}} &\leq C(a_k + 1)\varepsilon_k^2 \quad \text{in } \overline{B_{7/8}^+}(\phi_k), \\ \|g_k\|_{L^\infty} &\leq C(a_k + 1)\varepsilon_k^2 \quad \text{in } \overline{B_1^+}(\phi_k). \end{aligned}$$

Set

$$\tilde{\phi}_k(x) = \frac{\phi_k(x) - x_n}{\varepsilon_k},$$

$$\gamma_k := \phi_k + g_k,$$

and

$$\tilde{\gamma}_k(x) = \tilde{\phi}_k + \frac{g_k}{\varepsilon_k} = \frac{\phi_k(x) - x_n}{\varepsilon_k} + \frac{g_k}{\varepsilon_k}.$$

As shown in [DFS1], (the graph of) $\tilde{\phi}_k$ converges uniformly to (the graph of) $\tilde{\phi}$ on $B_{1/2} \cap \{x_n > 0\}$.

Thus, from the L^∞ estimates for g_k , also $\tilde{\gamma}_k$ converges uniformly to $\tilde{\phi}$ on $B_{1/2}$. Since \tilde{u}_k converges uniformly to \tilde{u} and $\tilde{\phi}$ touches \tilde{u} strictly by below at x_0 , we conclude that there exist a sequence of constants $c_k \rightarrow 0$ and of points $x_k \rightarrow x_0$ such that the function

$$\psi_k(x) = \gamma_k(x + \varepsilon_k c_k e_n)$$

touches u_k by below at $x_k \in B_1^+(u_k) \cup F(u_k)$. We claim that x_k cannot belong to $B_1^+(u_k)$. Otherwise, in a small neighborhood N of x_k we would have that

$$\mathcal{L}_k \psi_k = \Delta \phi_k > \varepsilon_k^4 \geq f_k = \mathcal{L}_k u_k, \quad \psi_k < u_k \text{ in } N \setminus \{x_k\}, \psi_k(x_k) = u_k(x_k),$$

a contradiction.

Thus $x_k \in F(u_k) \cap \partial B_{\frac{1}{B\varepsilon_k}}(y + e_n(\frac{1}{B\varepsilon_k} - M\varepsilon_k - \varepsilon_k c_k))$. For simplicity we call

$$\mathcal{B}_k := B_{\frac{1}{B\varepsilon_k}}(y + e_n(\frac{1}{B\varepsilon_k} - M\varepsilon_k - \varepsilon_k c_k)).$$

Let N_ρ be a small neighborhood of x_k of size ρ . Since

$$\|u_k^-\|_\infty \leq \varepsilon_k^2, \quad u_k^+ \geq (x_n - \varepsilon_k)^+,$$

as in the proof of Harnack inequality, using the fact that $x_k \in F(u_k) \cap \partial \mathcal{B}_k$ we can conclude by the comparison principle that

$$u_k^-(x) \leq c\varepsilon_k^2 W_k, \quad \text{in } N_\rho \setminus \mathcal{B}_k$$

where $\mathcal{L}_k W_k = -1$ in $N_\rho \setminus \mathcal{B}_k$, $W_k = 0$ on $N_\rho \cap \partial \mathcal{B}_k$, $W_k = 1$ on $\partial N_\rho \setminus \mathcal{B}_k$.

Let

$$(4.19) \quad \Psi_k(x) = \begin{cases} \psi_k(x) & \text{in } \mathcal{B}_k \cap N_\rho \\ -\varepsilon_k^2 W_k & \text{in } N_\rho \setminus \mathcal{B}_k \end{cases}$$

Then $\mathcal{L}_k \Psi_k \geq f_k$ in $\mathcal{B}_k \cap N_\rho$ and $N_\rho \setminus \mathcal{B}_k$.

We reach a contradiction if we show that

$$|\nabla_{A_k} \Psi_k^+|^2 - |\nabla_{A_k} \Psi_k^-|^2 > 1, \quad \text{on } F(\Psi_k).$$

Since

$$|\nabla_{A_k} \Psi_k^+|^2 - |\nabla_{A_k} \Psi_k^-|^2 \geq (1 - \varepsilon_k^2) |\nabla \Psi_k^+|^2 - (1 + \varepsilon_k^2) |\nabla \Psi_k^-|^2,$$

this follows from the formula for Ψ_k for k large enough, because $p > 0$. We finally reached a contradiction.

Step 3 – Contradiction. In this step we can argue as in the final step of the proof of Lemma 4.1 in [D]. \square

5. THE PROOF OF THEOREM 1.5

In this section we provide the proof of Theorem 1.5. The proof follows via a blow-up argument and our flatness Theorem 1.4, as in Section 6.2 of [DFS1]. The extra ingredient in that argument was the regularity theory developed by Caffarelli in [C1] in the homogeneous case. Here we provide a different proof of that result, based on a Weiss type monotonicity formula and our flatness Theorem 1.4. The same strategy has been employed in [DS].

Precisely, we have the following result.

Theorem 5.1. *Let u be a viscosity solution to*

$$(5.1) \quad \begin{aligned} \Delta u &= 0, & \text{in } B_1(u^+) \cup B_1(u^-), \\ (u_\nu^+)^2 - (u_\nu^-)^2 &= 1, & \text{on } F(u) \end{aligned}$$

with $0 \in F(u)$. If $F(u)$ is a Lipschitz graph in B_1 , then $F(u)$ is $C^{1,\gamma}$ in $B_{1/2}$, with norm controlled by a universal constant.

Let

$$E(u, r) := \int_{B_r} (|\nabla u|^2 + \alpha^2 \chi_{\{u>0\}} + \beta^2 \chi_{\{u<0\}}) dx, \quad \alpha^2 - \beta^2 = 1,$$

and define

$$(5.2) \quad \Phi_u(r) := r^{-n} E(u, r) - r^{-1-n} \int_{\partial B_r} u^2 d\mathcal{H}^{n-1}.$$

The proof of Theorem 5.1 is based on a Weiss-Type monotonicity formula for the function Φ_u . In the case when u is a critical point for the energy functional E (with respect to domain variations), then the proof of this formula is contained in [W]. In our context, we need a formula for viscosity solutions. Before the proof we remark that the rescaling

$$u_\lambda(X) := \lambda^{-1} u(\lambda X)$$

satisfies

$$(5.3) \quad \Phi_{u_\lambda}(r) = \Phi_u(\lambda r).$$

Theorem 5.2. *Let u be a viscosity solution to (5.1) in B_1 and assume that $F(u)$ is a Lipschitz graph. Then $\Phi_u(r)$ is monotone increasing for $0 < r \leq 1$. Moreover Φ_u is constant if and only if u is homogeneous of degree 1.*

Proof. First observe, by our flatness Theorem 1.4, that the free boundary condition is satisfied almost everywhere on $F(u)$. As mentioned before, by Theorem 3.2 [W] it is sufficient to prove that u is a critical point for the energy functional E , with respect to domain variation. Precisely, for every $\phi \in C_0^1(B_1, \mathbb{R}^n)$ u satisfies

$$(5.4) \quad \begin{aligned} 0 &= -\frac{d}{d\epsilon} E(u(x + \epsilon\phi(x)))|_{\epsilon=0} \\ &= \int_{B_1} (|\nabla u|^2 \operatorname{div} \phi - 2\nabla u D\phi \nabla u + \alpha^2 \chi_{\{u>0\}} \operatorname{div} \phi + \beta^2 \chi_{\{u<0\}} \operatorname{div} \phi). \end{aligned}$$

Let u be our viscosity solution and $\phi \in C_0^1(B_1, \mathbb{R}^n)$. Call

$$H(u) := \int_{B_1} (|\nabla u|^2 \operatorname{div} \phi - 2\nabla u D\phi \nabla u + \alpha^2 \chi_{\{u>0\}} \operatorname{div} \phi + \beta^2 \chi_{\{u<0\}} \operatorname{div} \phi).$$

An easy computation shows that in $B_1^\pm(u)$,

$$\langle \nabla |\nabla u|^2, \phi \rangle + 2\nabla u D\phi \nabla u = 2\langle \nabla \langle \phi, \nabla u \rangle, \nabla u \rangle.$$

Then, integrating by parts and using that ϕ is compactly supported in B_1 we get

$$\begin{aligned} H(u) &= - \int_{B_1 \cap \{u>0\}} (\langle \nabla |\nabla u|^2, \phi \rangle + 2\nabla u D\phi \nabla u) + \int_{F(u)} |\nabla u^+|^2 \langle \phi, \nu \rangle \\ &\quad - \int_{B_1 \cap \{u<0\}} (\langle \nabla |\nabla u|^2, \phi \rangle + 2\nabla u D\phi \nabla u) - \int_{F(u)} |\nabla u^-|^2 \langle \phi, \nu \rangle \\ &\quad + \int_{F(u)} (\alpha^2 - \beta^2) \langle \phi, \nu \rangle \\ &= -2 \int_{B_1 \cap \{u>0\}} \langle \nabla \langle \phi, \nabla u \rangle, \nabla u \rangle + \int_{F(u)} (|\nabla u^+|^2 - |\nabla u^-|^2) \langle \phi, \nu \rangle \\ &\quad - 2 \int_{B_1 \cap \{u<0\}} \langle \nabla \langle \phi, \nabla u \rangle, \nabla u \rangle + \int_{F(u)} \langle \phi, \nu \rangle, \end{aligned}$$

where ν denotes the unit normal vector to $F(u)$ pointing towards $B_1^+(u)$. In the last equality we used that $\alpha^2 - \beta^2 = 1$.

Integrating by parts again, and using that u is harmonic in $B_1^\pm(u)$ and ϕ is compactly supported in B_1 we get

$$\begin{aligned} H(u) &= -2 \int_{F(u)} \langle \phi, \nabla u^+ \rangle \langle \nabla u^+, \nu \rangle + \int_{F(u)} (|\nabla u^+|^2 - |\nabla u^-|^2) \langle \phi, \nu \rangle \\ &\quad + 2 \int_{F(u)} \langle \phi, \nabla u^- \rangle \langle \nabla u^-, \nu \rangle + \int_{F(u)} \langle \phi, \nu \rangle. \end{aligned}$$

Since $\nu = \frac{\nabla u^+}{|\nabla u^+|} = -\frac{\nabla u^-}{|\nabla u^-|}$ a.e. on $F(u)$ we get that

$$H(u) = - \int_{F(u)} (|\nabla u^+|^2 - |\nabla u^-|^2) \langle \phi, \nu \rangle + \int_{F(u)} \langle \phi, \nu \rangle = 0,$$

because the free boundary condition is satisfied a.e. \square

Remark 5.3. If u_k are viscosity solutions with Lipschitz free boundaries with uniform Lipschitz bound which converges uniformly to u on compact sets, then it follows that

$$(5.5) \quad \Phi_{u_k}(r) \rightarrow \Phi_u(r).$$

Moreover, if u satisfies the assumptions of Theorem 1.5 then $\Phi_u(r)$ is bounded below as $r \rightarrow 0$. This means that

$$\Phi_u(0^+) = \lim_{r \rightarrow 0^+} \Phi_u(r) \quad \text{exists}$$

and by (5.5)-(5.3) any blow-up sequence u_λ converges uniformly on compact sets (up to a subsequence) to a homogeneous of degree 1 solution u_0 .

Remark 5.4. By the monotonicity formula of Alt-Caffarelli-Friedman [ACF], either u_0 is a two-plane solution U_β for $\beta > 0$ or $u_0^- \equiv 0$.

Consider the one-phase problem:

$$(5.6) \quad \begin{aligned} \Delta U &= 0, & \text{in } \{U > 0\} \\ |\nabla U|^2 &= 1, & \text{on } F(U). \end{aligned}$$

Definition 5.5. A global viscosity solution to (5.6) which is homogeneous of degree 1 and has Lipschitz free boundary is called a *Lipschitz cone*.

We say that a Lipschitz cone is trivial if it coincides (up to rotations) with the one-plane solution $U_0 = x_n^+$. We wish to prove the following theorem.

Theorem 5.6. *All Lipschitz cones are trivial.*

To this aim, we will use a standard dimension reduction argument. A point $x_0 \in F(U)$ such that $F(U)$ is $C^{1,\gamma}$ in a neighborhood of x_0 , is called regular. Points that are not regular, are called singular.

Lemma 5.7. *Assume U is a Lipschitz cone in \mathbb{R}^n and $x_0 = e_1 \in F(U)$. Then, any blow-up sequence*

$$V_\lambda(x) = \lambda^{-1}U(x_0 + \lambda x)$$

has a subsequence $V_{\lambda_k}, \lambda_k \rightarrow 0$ which converges uniformly on compact sets to $V(x_2, \dots, x_n)$ with V a Lipschitz cone in \mathbb{R}^{n-1} . Moreover if x_0 is a singular point for $F(U)$, then V is a non-trivial cone.

Proof. From the fact that U is homogeneous of degree 1 and from the formula for V_λ we get that

$$\begin{aligned} V_\lambda(x) &= \lambda^{-1}(1 + t\lambda)^{-1}U((1 + t\lambda)(x_0 + \lambda x)) \\ &= (1 + t\lambda)^{-1}V_\lambda(tx_0 + (1 + t\lambda)x). \end{aligned}$$

Letting $\lambda = \lambda_k \rightarrow 0$ we obtain that

$$V(x) = V(tx_0 + x), \quad \text{for all } t.$$

Thus, V is constant in the $x_0 = e_1$ direction and by Remark 5.3 is homogeneous of degree 1. Now, it is easily checked from the definition that $V(x_2, \dots, x_n)$ is a viscosity solution in \mathbb{R}^{n-1} , and clearly V is a Lipschitz cone.

The final statement follows from the flatness Theorem 1.4. \square

Assume that U is a non-trivial Lipschitz cone in \mathbb{R}^n for some dimension n . Then by Lemma 5.7 we obtain that if $F(U)$ has a singular point different than the origin, then there exists a non-trivial Lipschitz cone in \mathbb{R}^{n-1} . By repeating this dimension reduction argument, we can assume that there is a dimension $k < n$ and a non-trivial cone in \mathbb{R}^{k+1} which is regular at all points except at 0. Thus, Theorem 5.6 reduces to the following proposition.

Proposition 5.8. *All Lipschitz viscosity cones whose free boundary is C^∞ outside of the origin are trivial.*

Proof. Let U be a Lipschitz viscosity cone which is smooth outside the origin, and denote by L the Lipschitz norm of $F(U)$ as a graph in the e_n direction. We want to show that U is trivial.

We prove the proposition by induction on n . The case $n = 1$ is obvious. Assume the statement holds for $n - 1$.

By Proposition 5.9 below, U is monotone in the cone of directions

$$\mathcal{C} := \{\xi = (\xi', \xi_n) \in \mathbb{R}^n : \xi_n \geq L|\xi'|\},$$

since $F(U)$ is a Lipschitz graph with respect to any direction $\xi \in \mathcal{C}^o$. Moreover there is a direction $\tau \in \partial\mathcal{C}$, $|\tau| = 1$ such that τ is tangent to $F(U)$ at some point $X_0 \in F(U) \setminus \{0\}$. Then,

$$U_\tau \geq 0 \quad \text{in } \{U > 0\}.$$

If $U_\tau = 0$ at some point in $\{U > 0\}$ then $U_\tau \equiv 0$, thus U is constant in the τ direction, and by dimension reduction we can reduce the problem to $n-1$ dimensions thus by the induction assumption U is trivial. Otherwise $U_\tau > 0$ in $\{U > 0\}$ and by Hopf Lemma

$$U_{\tau\nu} > 0 \quad \text{on } F(U) \setminus \{0\}.$$

This contradicts the free boundary condition, $U_\nu^2 = 1$ on $F(U) \setminus \{0\}$. \square

In the proof above we used the following result. Its proof is contained for example in [CS] and it is a consequence of the Boundary Harnack Inequality.

Proposition 5.9. *Assume that $v \geq 0$ solves $\Delta v = 0$ in $B_1^+(v)$, and that $F(v)$ is a Lipschitz graph in the e_n direction in B_1 with Lipschitz constant L , and $0 \in F(v)$. Then v is monotone in the e_n direction in B_δ , with δ depending on L and n .*

We are now finally ready to exhibit the proof of Theorem 5.1.

Proof of Theorem 5.1. First, we show that given a viscosity solution u with Lipschitz free boundary in B_1 , $0 \in F(u)$, we can find $\sigma > 0$ small depending on u such that $F(u)$ is a $C^{1,\gamma}$ graph in B_σ . Indeed, there exists a blow-up sequence u_{λ_k} which converges to a Lipschitz viscosity cone (see Remark 5.3), that in view of Remark 5.4 and Theorem 5.6 is of the form U_β for $\beta \geq 0$. The conclusion now follows from our flatness Theorem 1.4.

Next we use compactness to show that σ depends only on the Lipschitz constant L of $F(u)$. For this we need to show that $F(u)$ is $\bar{\varepsilon}$ -flat in B_r for some $r \geq \sigma$ depending on L . If by contradiction no such σ exists, then we can find a sequence of solutions u_k and of $\sigma_k \rightarrow 0$ such that u_k is not $\bar{\varepsilon}$ -flat in any B_r with $r \geq \sigma_k$. Then the u_k converge uniformly (up to a subsequence) to a solution u_* and we reach a contradiction since $F(u_*)$ is $C^{1,\gamma}$ in a neighborhood of 0 by the first part of the proof. \square

6. PERRON'S SOLUTIONS

In this section we apply our results to the Perron's solution constructed in [DFS3], where we used the following definition of weak or viscosity solution. Given a continuous function v on Ω , we say that a point $x_0 \in F(v)$ is regular from the right (resp. left) if there is a ball $B \subset \Omega^+(v)$ (resp. $B \subset \Omega^-(v)$), such that $\bar{B} \cap F(v) = \{x_0\}$. Let us denote by $\nu(x_0)$ the unit normal at the point x_0 . $A(x_0)\nu(x_0)$ is the co-normal to ∂B at x_0 pointing toward $\Omega^+(v)$. For coherence with the rest of the paper, in what follows

$$G(\beta, \nu, x) = \sqrt{\langle A\nu, \nu \rangle^{-1} + \beta^2}.$$

However the reader should notice that the arguments below continue to work for a general G , as considered in [DFS3].

Definition 6.1. A function $u \in C(\Omega)$ is a weak solution of (1.1) if

- (i) $\mathcal{L}u = f$ in $\Omega^+(u) \cup \Omega^-(u)$ in the weak sense;
- (ii) (a) If $x_0 \in F(u)$ is regular from the right with touching ball B , then in a neighborhood of x_0

$$u^+ \geq \alpha \langle x - x_0, \nu(x_0) \rangle^+ + o(|x - x_0|), \quad \alpha \geq 0,$$

in B and

$$u^- \leq \beta \langle x - x_0, \nu(x_0) \rangle^- + o(|x - x_0|), \quad \beta \geq 0,$$

in B^c with equality along non-tangential domain and

$$\alpha \leq G(\beta, \nu_0, x_0).$$

- (b) If $x_0 \in F(u)$ is regular from the left with touching ball B , then in a neighborhood of x_0

$$u^- \geq \beta \langle x - x_0, \nu(x_0) \rangle^+ + o(|x - x_0|), \quad \text{in } B, \quad \text{with } \beta \geq 0,$$

and

$$u^+ \leq \alpha \langle x - x_0, \nu(x_0) \rangle^+ + o(|x - x_0|), \quad \text{in } B^c, \quad \text{with } \alpha \geq 0,$$

with equality along non-tangential domain and

$$\alpha \geq G(\beta, \nu_0, x_0).$$

Lemma 6.2. *Definition 6.1 and Definition 1.2 are equivalent.*

Proof. Let u be a weak solution as in Definition 6.1. Assume $v \in C^{1,\bar{\gamma}}(\overline{B^+(v)}) \cap C^{1,\bar{\gamma}}(\overline{B^-(v)})$, with $F(v) \in C^2$, touches u from below at $x_0 \in F(v)$. Then we need to show

$$|\nabla v^+(x_0)| \leq G(|\nabla v^-(x_0)|, \nu_0, x_0).$$

Indeed, $v \leq u$ in a neighborhood of x_0 and x_0 is regular from the right. Thus

$$u^+ \geq |\nabla v^+(x_0)| \langle \nu(x_0), x - x_0 \rangle^+ + o(|x - x_0|),$$

$$u^- \leq |\nabla v^-(x_0)| \langle \nu(x_0), x - x_0 \rangle^- + o(|x - x_0|),$$

and by part (ii)-(b) in Definition 6.1, we obtain the desired inequality. A similar argument works for test functions touching u from above.

Assume now that u is a viscosity solution in the sense of Definition 1.2 (we consider for simplicity only the case (ii)-(a)). If $x_0 \in F(u)$ is regular from the right with touching ball B , then, by Lemmas 2.2 and 2.3 in [DFS3], we can write

$$u^+ \geq \alpha \langle x - x_0, \nu(x_0) \rangle^+ + o(|x - x_0|), \quad \alpha \geq 0,$$

with non-tangential equality in B , and

$$u^- \leq \beta \langle x - x_0, \nu(x_0) \rangle^- + o(|x - x_0|), \quad \alpha \geq 0.$$

with non-tangential equality in B^c .

We show that $\alpha \leq G(\beta, \nu(x_0), x_0)$. Assume by contradiction that

$$\alpha > G(\beta, \nu(x_0), x_0).$$

After a smooth change of variables that flattens the surface ball we may assume that $B = B_2$, $B_2^+ \subset \Omega$, with $x_0 = 0 \in \partial\Omega \cap \partial B_2$ and $\nu(0) = e_1$. We keep the same notation u and \mathcal{L} for the transformed u and the new operator, which is uniformly elliptic with ellipticity constant of the same order of λ, Λ . Let $w(x) = \varphi(x) / \varphi_{x_1}(0)$

where $\varphi(x)$ is the \mathcal{L} -harmonic measure in B_2^+ of $S_2^+ = \partial B_2 \cap \{y_1 > 0\}$. For $k \geq 1$, define

$$\alpha_k = \sup \left\{ \tilde{\alpha} : u(x) \geq \tilde{\alpha} w(x) \quad \text{for every } x \in B_{1/k}^+ \right\}.$$

Then $\{\alpha_k\}_{k \in \mathbb{N}}$ is nondecreasing and (see Lemma 2.3 in [DFS3]), $\alpha_k \rightarrow \alpha \geq 0$. Moreover

$$(6.1) \quad u(x) = \alpha w(x) + o(|x|) \quad \text{as } x \rightarrow 0, x \in B_1^+.$$

Thus for each k sufficiently large, there exists a $C^{1,\bar{\gamma}}(\overline{B_{1/k}^+})$ function $\tilde{\alpha}_k w(x)$, that vanishes on $x_1 = 0$ and touches from below u in $B_{1/k}^+$, at 0, with $\tilde{\alpha}_k \rightarrow \alpha$.

Let $v(x) = \psi(x) / \psi_{x_1}(0)$, where ψ is the \mathcal{L} -harmonic measure in B_2^- of $\partial B_2 \cap \{y_1 < 0\}$. Define, for $k \geq 1$,

$$\beta_k = \inf \left\{ \tilde{\beta} : u^-(x) \leq \tilde{\beta} v(x) \quad \text{for every } x \in B_{1/k}^- \right\}.$$

Then $\{\beta_k\}_{k \in \mathbb{N}}$ is nonincreasing and (see Lemma 2.2 in [DFS3]), $\beta_k \rightarrow \beta \geq 0$. Thus, for each k sufficiently large, there exists a $C^{1,\bar{\gamma}}(\overline{B_{1/k}^-})$ function $\tilde{\beta}_k v(x)$, that vanishes on $x = 0$ and touches from above u^- in $B_{1/k}^-$, at 0, with $\tilde{\beta}_k \rightarrow \beta$. As a consequence, the functions

$$h_k = \begin{cases} \tilde{\alpha}_k w, & x \in B_{1/k}^+ \\ -\tilde{\beta}_k v, & x \in B_{1/k}^- \end{cases}$$

touch from below u at 0 in $B_{1/k}$ and therefore we must have $\tilde{\alpha}_k \leq G(\tilde{\beta}_k, e_1, 0)$. Since $\tilde{\alpha}_k \rightarrow \alpha$ and $\tilde{\beta}_k \rightarrow \beta$, we obtain a contradiction to $\alpha > G(\beta, \nu_0, x_0)$. \square

Finally, to obtain Theorem 1.6 we need a compactness result, which is available already for viscosity solutions. We state here a compactness theorem specific for Perron's solutions, as it is interesting in its own.

Theorem 6.3. (Compactness). *Let u_k be a sequence of Perron solutions to*

$$\begin{aligned} \mathcal{L}_k u_k &= \operatorname{div}(A_k(x) \nabla u) = f_{1,k} && \text{in } \Omega^+(u_k) \\ \mathcal{L}_k u_k &= \operatorname{div}(A_k(x) \nabla u) = f_{2,k} \chi_{\{u_k < 0\}} && \text{in } \Omega^-(u_k) \\ (u_k^+)_\nu &= G_k((u_k^-)_\nu, \nu_0, x_0) && \text{on } F(u_k) \end{aligned}$$

with \underline{u}_k a sequence of minorants s.t.

$$\underline{u}_k \leq u_k.$$

Assume that $A_k \rightarrow A$, $G_k \rightarrow G$, $f_{i,k} \rightarrow f_i$, $i = 1, 2$, and $\underline{u}_k \rightarrow \underline{u}$ uniformly and that the assumptions on $A_k, G_k, f_{i,k}$, $i = 1, 2$, and \underline{u}_k are satisfied uniformly.

Then, if $u_k \rightarrow u$ uniformly in D , u is a weak solution of the limiting free boundary problem in D .

Proof. The proof follows as in Lemma 6.3 and 7.1 in [DFS3], with the sequence u_k playing the role of the sequence of supersolutions w_k there. \square

Proof of Theorem 1.6. We may suppose that $x_0 = 0$ and that $\nu = e_n$ is the measure-theoretical normal to $F^*(u)$ at 0. Rescale by setting $u_r(x) = \frac{1}{r} u(rx)$. Since $\Omega^+(u_r) = \Omega_r^+(u) \equiv \{x : rx \in \Omega^+(u)\}$, it follows that $\Omega^+(u_r)$ and $\Omega^-(u_r)$ converge locally in measure to the half spaces $x_n > 0$ and $x_n < 0$, respectively.

Moreover, from the uniform positive density of $\Omega^+(u)$ along $F(u)$, given $\varepsilon > 0$ and a ball B centered at the origin, for $r \leq r_0(\varepsilon, B)$, small, we infer

$$(6.2) \quad \Omega^+(u_r) \cap B \subset \{x_n > -\varepsilon\} \cap B$$

and therefore also

$$(6.3) \quad \Omega^-(u_r) \cap B \supset \{x_n < -\varepsilon\} \cap B.$$

Now, from the equilipschitz continuity of u_r , we can extract a subsequence $u_j = u_{r_j}$ uniformly convergent to U in every compact subset of \mathbb{R}^n . From the compactness theorem, U is a global solution of a two phase problem for the Laplace operator, with free boundary condition $U_{x_n}^{+2} - U_{x_n}^{-2} = 1$. The above argument and the Lipschitz continuity of U , implies that U must be a two-plane solution:

$$U(x) = \alpha x_n^+ - \beta x_n^-.$$

Thus, (j large)

$$|u_j - U| < \varepsilon,$$

and using the nondegeneracy of u and (6.2),(6.3), it also follows that $F(u_j)$ is contained in a strip $|x_n| \leq c\varepsilon$, c universal.

Then, the regularity Theorem 1.4 implies that $F(u)$ is a $C^{1,\gamma}$ surface, near the origin. In particular, α and β must be independent of the selected subsequence. \square

7. APPLICATION TO THE PRANDTL-BATCHELOR MODEL

In this section we apply our results to the classical Prantl-Batchelor model in hydrodynamics, proposed by Batchelor back in 1956 [B1]. We restate it in our notation the following way.

In a bounded 2d domain Ω a constant vorticity flow is immersed in an irrotational flow. On the unknown interface between the two flows, the jump of the squares of the exterior and the interior speeds is a prescribed constant. Thus given two constants $\mu > 0, \omega > 0$, one looks for a function u , with $u = \mu$ on $\partial\Omega$, satisfying

$$(7.1) \quad \begin{cases} \Delta u = 0 & \text{in } \Omega^+(u), \quad \Delta u = \omega & \text{in } \Omega^-(u) \\ |\nabla u^+|^2 - |\nabla u^-|^2 = \sigma & \text{on } F(u) = \Omega \cap \partial\Omega^+(u) \end{cases}$$

where $\sigma > 0$.

When Ω is convex, Acker [A], using a variational method, gives sufficient conditions for the existence of a solution U with *convex* free boundary, such as Ω is large enough or there exists a classical “inner” solution (i.e., a supersolution in our setting). These solutions are classical in the sense that U^+ and U^- are C^1 up to the free boundary and the condition across is satisfied in the pointwise sense. Actually, the results of Acker hold in any dimension $n \geq 2$, with $\sigma = \sigma(x)$ continuous and bounded. From Theorem 1.5, we deduce that $F(U)$ is locally a $C^{1,\gamma}$ graph.

When Ω is not convex, the theory is largely incomplete (see [EM]). In the context of viscosity solutions it is known that solutions are Lipschitz, as shown in [CJK], but neither existence nor regularity is known. What we can prove is the following. Assume that f is a conformal map of Ω onto the unit disk B_1 centered at the origin,

with $0 < m \leq |f'| \leq M$. Call $\hat{u} = u \circ f$. Problem (7.1) transforms into

$$(7.2) \quad \begin{cases} \Delta \hat{u} = 0 & \text{in } B_1^+(\hat{u}), \Delta \hat{u} = |f'|^2 \omega & \text{in } B_1^-(\hat{u}) \\ |\nabla \hat{u}^+|^2 - |\nabla \hat{u}^-|^2 = |f'|^2 \sigma & \text{on } F(\hat{u}). \end{cases}$$

Clearly, if u is a viscosity solution of (7.1) then \hat{u} is a viscosity solution of (7.2).

Let us look for radial solutions U_h of problem (7.2), with $h^2\omega$ and $h^2\sigma$ replacing $|f'|^2\omega$ and $|f'|^2\sigma$ respectively, where $h > 0$. It turns out that, if $z_0 = z_0(\mu, \omega, h)$ is the minimum of the function

$$f(\rho; h, \mu) = \rho^{-2} (\log \rho)^{-2} \mu^2 - \frac{1}{4} h^2 \omega \rho^2$$

over the interval $(0, 1)$, and the condition

$$(7.3) \quad h^2 \sigma > \max\{0, z_0\}$$

holds, then it is easy to check that there exist two radial solutions $U_{h,1}$ and $U_{h,2}$, whose free boundary is given by circles C_{ρ_1} and C_{ρ_2} , where $\rho_1(h, \omega, \mu, \sigma) < \rho_2(h, \omega, \mu, \sigma)$ are the roots (in the interval $(0, 1)$) of the equation

$$f(\rho; h, \mu) = h^2 \sigma.$$

In particular, (7.3) holds for every h and $\sigma > 0$, if $h^2\omega \geq 4e\mu$.

Observe now that, under the condition (7.3), the radial solutions $U_{m,1}$ and $U_{m,2}$ are classical supersolutions of problem (7.2), while $U_{M,1}, U_{M,1}$ are classical subsolutions. Since, in particular

$$\rho_2(M, \omega, \mu, \sigma) > \rho_2(m, \omega, \mu, \sigma) > \rho_1(m, \omega, \mu, \sigma)$$

it follows that $U_{M,2} < U_{m,1} < U_{m,2}$ in B_1 . From Theorem 1.3 in [DFS3] and Theorem 1.6 we deduce the following result.

Theorem 7.1. *Assume that*

$$(7.4) \quad m^2 \sigma > \max\{0, z_0(\mu, \omega, m)\}.$$

Then there exists a Perron solution u of the Prandtl-Batchelor problem (7.1). In particular, the free boundary $F(u)$ has H^1 finite measure and in a neighborhood of any point of the reduced boundary, $F^(u)$ is a $C^{1,\gamma}$ curve.*
