Study description	Assess how corals acclimatize, in terms of trophic shifts (autotrophy vs heterotrophy), to low pH conditions
Research sample	Zooxanthellate scleractinian coral <i>Balanophyllia europaea</i> specimens were used for this study. Some specimens were measured in the field (photosynthetic efficiency; N = 353 in total of random sizes) and some were collected for physiological measurements in the lab (N = 36 in total). Collected samples were all ca. 10 mm in length (maximum axis of oral pole)

Data collection	A total of 36 samples were collected, all with average size of ca. 10 mm in length (maximum axis of oral pole). We chose this size as this is the average size of these corals based on previous studies

Collected samples were all the same size to collect less samples thus minimizing the impact of removing individuals and preserving both the demographic and genetic structure of the natural populations
